## MISCELLANEOUS ITEMS

Burke Belkmap sent in this short article on the Overt-Motivator Sequence, which is of general interest:

One of the most important mechanisms of the mind in current Scientology theory is the Overt-Motivator Sequence. While we have been hearing of the mechanism for some years, its importance has been really understood only during the last year or so. There are, however, some aspects of the situation which might bear looking at in more detail.

An experience is an Overt Act or a Motivator only by consideration. This point has often been overlooked or poorly understood. Let's take an example: Joe sells Bill a pocket knife for \$.25. This experience may fall into one of three categories. In the first case we look at, both Joe and Bill are perfectly satisfied with the transaction, and it is filed memory-wise simply as an experience. However, let's suppose Joe decides that the knife, having a broken blade, is not worth \$.25, and that he has gypped Bill in selling it to him. This makes the incident, for Joe, an Overt Act. The third possibility is this: Joe decides that since he paid \$2.00 for the knife, Bill took advantage of him by buying it for \$.25. The incident, for Joe, is then a Motivator. In a similar manner, ty his own considerations, Bill can make either an Overt Act or a Motivator out of the simple experience.

An experience, in itself, no matter how destructive, is not necessarily aberrative. Aberration occurs only through considerations over-laid on the experience by the individual and then misowned. The primary consideration leading to aberration is that it was an Overt Act, in other words, a harmful act on his part that he should not have done. From this stems the secondary aberrative consideration of the Motivator which, as we know, is based upon a previous Overt Act.

The following interesting case was reported by Cathy Gogerly, Director of Processing in Melbourne:

"...Have a pc who was a step 6 preclear, June-July 1958. Since then he has been a black case. Couldn't see any pictures. Ran him on O/W on the auditor who "cleared" him, and his pictures have turned on. We are now running O/W on "an auditing room" to clean the case up thoroughly."

Cathy also wrote that "the Bulletin of November 3rd, 1960, "Failed Help", has been more help to me and this HGC than any bulletin since "Model Session". (Note: These bulletins will be available in PABs, if not already published.)

Director of Govt. Relations in Melbourne, Denny Gogerly, drew Ron's attention to the following excerpt from a letter sent out by W. Henry MacFarland, Jr., Chairman of the American Flag Committee, a body which watches over the freedom and rights of Americans and others:

"...But, the most frightening information came when Nixon turned the conversation to the subject of mental health. Reaching into his brief-case, he withdrew about twenty assorted papers, monographs and photo-offsets, which he spread upon the table. "These," he said, "will give you an idea of what the United Nations is planning for us next year." He went on to explain that two of the UN's "specialized agencies," UNESCO and the World Health Organization, have been in the process of preparing a series of "recommendations" for "model mental health legislation" in the continued....

various UN-member States. These proposals will be ready for implementation when our Congress convenes in January. Representatives of the UN have already contacted key members of the Senate and House, he continued, and have arranged that the UNESCO-WHO program be introduced in the form of at least twelve separate bills. In addition, two treaties are being drafted to bring education and mental health under international control.

Since receiving this material, I have studied every document in detail, and the contents are sickening. The program which they outline contains all of the worst features of the <u>Alaska Mental Health Act of 1956</u>. If only a half of the proposals should be enacted by Congress, an American citizen could be stripped of every freedom guaranteed him under the Constitution, simply by virtue of a mere accusation of being "Mentally ill".

Ron authorized the Org. in Washington to send 1,000 dollars to the American Flag Committee to combat the introduction of these "mental health" measures. Scientologists in America were instrumental in defeating the introduction of the Alaska Mental Health Act of 1956. Even though Nixon will not become President, it may be that the UN will try to introduce these measures. If you would like to help prevent this possibility, send a donation to the American Flag Committee, 2834, Almond Street, Philadelphia 34, Pennsylvania, mentioning specifically that you wish to block United Nations-sponsored "mental health" legislation.

Smokey Brand, staff member in Washington, sent in the following, as a possible explanation of why Step 6 fails:

Step 6 fails because, in making a mockup more solid, the bank is also made more solid. Why? Identification is the reason. A preclear is told to mock up a pencil and make it a little more solid. A pencil is used to write messages; messages are communication. To the reactive mind A equals A; so a pencil equals communication. A telephone pole holds up wires; conversations mass over these wires. Conversation is communication. A equals A equals A. A pencil equals communication equals a telephone pole. A telephone pole was once a tree; forests are composed of trees. The surface of some planets are covered by trees. Sometimes forests are destroyed by fire. So the surface of a planet is destroyed by fire. In the past the PC has destroyed a planet. So in making the mockup of a pencil a little more solid, he makes the facsimile of his destruction of a planet a little more solid. So he keys in a gigantic overt from the past. So with each mockup that makes a little more solid, he also makes more solid anything that he has identified with that mockup. So he has many, many overts keyed in and in restimulation. After the session he speeds swiftly down the highway, feeling guilty for all of these past overts. He sees a bridge approaching. He pulls over to let the bridge go by. So Step 6 fails.

Joe Belotte, Theory and Practice Instructor in the Academy at Washington, sent the following to Ron:

"In relation to theory 67 I got an idea that perhaps the E-meter might demonstrate which dynamic has to be taken off of which, 6th off 7th, or 7th off 6th on any particular pc. The idea is that maybe pc with usual consistent high tone arm would indicate take 7th off 6th, and low consistent tone arm would indicate 6th off 7th. This also may be reverse (low 7th off 6th, high 6th off 7th) or may not be true at all, still you may be interested in looking into it. If it proves true it should be VERY helpful."
