
"PERSONAL ROLLER COASTER"

Note: "Roller Coaster" is Scientologese for a case that goes up and down. It compares the case to a carnival roller coaster which is a little car on a track that goes up and shoots down over and over. Personal roller coaster is one who does this in the absence of outside influence. All roller coastering is caused by suppression and suppressives. Get well-get sick, etc.

When a case has "advanced" to upper grades and goes "bonkers" one can suspect he is heavily PTS. The PTS phenomena is termed "Personal Roller Coaster". Invariably the person has been found to have huge overts on one or more dynamics and always o/w's on Scientology.

The "Personal Roller Coaster" will make actual gains and slide, makes gains and slide and this happens because when he or she has case gains his confront opens up as well as "responsibility" level. He suddenly realizes the enormity of his overts, particularly on Dianetics and Scientology if these exist. Next the case will Roller Coaster because his confront is not on par with his ability to handle. He pulls the curtain down. He cannot permit himself to have a case gain.

The overts that the person has done, seem to horrible and monstrous much more than they actually are.

The fact of the matter is that the "Personal Roller Coaster" has been suppressive in the past as well as this lifetime.

Such cases are easily visible by actual observation of the person or via folder inspection of the case.

The data was previously listed in the HCOB 30 June 1967, Evidences of Aberration, and such cases were found in the Dianetic days and can be found in <u>Dianetics:</u> The Modern Science of Mental <u>Health</u>, but the term as such "Personal Roller Coaster" wasn't used.

"Personal Roller Coaster" has the following characteristics-

- 1. Large manifestations of HCOB 30 June 1967 Evidences of Aberration.
- 2. "Pc has improvement and has phenomena of nose dive" - LRH.
- R/S on intention of committing overt. 3.
- 4. "Self-punishment" - suicide, starvation etc.
- On a Joburg doesn't read or is very theety-weety. 5.
- 6. Caves in on being asked on the subject of overts.
- Person may attain high position of responsibility and trust 7. and do destructive actions.
- The case has difficulty conceiving he did anything wrong. 8.
- Falsely attested on auditing grades and OT Sections.
- 10. Suppressive to those in environment.
- 11. Natters.
- 12. Lies.
- 13. Makes environment unsafe.
- 14. When being audited has endless S & Ds, Remedies and Review patches.
- 15. Very reasonable and low confront of evil.

- 16. Stops on one or more dynamics and was stopped on one or more dynamics.
- 17. Withdraws on one or more dynamics and makes others withdraw on one or more dynamics.
- 18. Unmocks on one or more dynamics and has been unmocked on one or more dynamics.
- 19. Very choppy of upstats.
- 20. Delicate preclears.

When such a case is being audited the following must be done to remedy the case-

- 1. Good food and safe environment.
- 2. Rest (and possible seclusion if very essential the use of tranquilizer may be permitted and morphine)
- 3. Next work must be provided for the person to get attention extroverted.
- 4. WSU S & D (with close attention to ARC Brks, ARC B needles, dead thetan needles) to actual EP of FN.
- 5. List "What valence (identity) would be safe", being careful to follow Laws of Listing exactly as always.

The auditing of such a case must be followed up with a training program.
