Notes on C/S Instructions

The auditor's hat is to audit. The Case Supervisor, going by FOLDERS ONLY established the next action the auditor is to perform.

The C/S (Case Supervisor) only uses the folder, the record of what happened in the session as his assessment for the next action, as he knows that STANDARD Dianetics produces only STANDARD results. ALWAYS.

To keep Dianetics working it is imperative that the C/S's instructions get implicitly followed. They are to be duplicated by the auditor 100%. There are to be no additives, or for that matter actions left out. The auditor duplicates.

So if the C/S orders the use of an "existing list", he means just that. An EXISTING list. He does then not mean for you to go and copy the list, or make another list. He means the EXISTING list. And that you may well have to add to the list does not alter the fact that you use the list ordered.

And using the existing list of course automatically carries with it the use of another coloured ball point than the one the list was originally written in. Simple.

Similarly if the C/S orders you to flatten a particular chain, you fault flatten JUST THAT CHAIN, using the EXACT WORDING of that chain, and not a varied altered version. The feeling of "like a whatsit in my head", is not the same as the feeling of "like a goo going bong bong in my head". That is a different chain. And if you were to start mixing these separate chains you'll end up with 2 unflat chains in restimulation and a very unwell pc on your hands.

The C/S is not swayed by opinions and other occurrences which may influence his judgment. He is aloof and guides solely and only per Standard Technical data from HCOB's, Books and tapes.

It must once more be stressed that standard Dianetics works as well as the exactness and the duplication of Ron's data.

---

One point that may have been misunderstood is that one accepts the pc's data. This includes if the pc indicates to you that he has gone into an earlier incident. If you are halfway through running an incident and the pc volunteers that he has moved into another earlier incident on this chain, you do not then continue running the incident you were running, but accept his data. Your purpose is to reach and erase basic on the chain. And to not accept the pc's data that he has gone earlier (which really is a win for him as it denotes increased awareness and confront), is invalidation of the grossest order.

You now run the new incident exactly per standard Dianetic procedure. Steps 1 to 8, then A,B,C, and D etc..

• The first "solid/erasing?" test is done after two times through the incident. If the item needs to be run more than twice this step is done after every one time through the incident thereafter for that specific incident.

Then when one can run the next incident one runs that twice, checks "solid/erasure?", and the same again. If it has to be run more than twice one checks for solidity/erasure after every single time through.

It is more the exception than the rule that one has to run an incident more than two times (except when it is basic on the chain), but it can occur, and in such case the above rule applies.

As a further point. It may happen that the C/S orders you to "erase the last session or chain". And this is exactly what he means. "Yes" you say, but how can it be a chain, the guy has only been in Scientology for 3 days?" Okay. How many other practices may he have been involved in before coming into a Scientology Organization? This last session which the C/S orders to be erased may well carry the same "feeling" as the 56000 hours he spent on the psychoanalysts couch. And if that is for the pc an earlier item on that chain, well you run it. The fact that the C/S orders erasure of the last session by itself already denotes that gross technical outnesses must have occurred in that session. -s

If per chance you do not understand the C/S instructions, you do not verbally ask the milkman, or the C/S himself for that matter. (AN AUDITOR NEVER NEVER NEVER DISCUSSES A CASE WITH THE C/S).

You write a polite note to the C/S, stating exactly what it is you want clarified and send the folder back.

YOU NEVER NEVER NEVER JUST GO AHEAD AND AUDIT SOMETHING ANYWAY. And you can only duplicate the C/S if you really understand what your instructions are. A lack in your understanding can wrap a pc around a telegraph pole.

And not until you have received the folder back, and your query clarified do you audit. And as your query is usually already based on a misunderstood YOU have, the C/S will have picked this up, and ordered you to some starrate checkouts to rectify the shortcoming. These orders you will also follow before auditing the pc.
