URGENT--IMPORTANT FLOATING NEEDLES

(Cancels HCOBs 6 May 69 "R3R Revised", Page4, Paragraph called "F/Ns vs Erasure."; HCOB 14 May 69, Paragraph one up to "Tone Arm Position"; 23 June 69 "F/N", portion from "When a Key-Out occurs...sent to Review for a Scientology Green Form."; HCOB 3 July 69, Health Form and Somatics, Para 2, para. "Ending Off".

This HCOB is to *rate checked out by all HDCs, all HDGs, and all Class VIIIs, immediately upon receipt, before they go and audit Dianetics again. It is of very important value.

This HCOB is going to provide you with a series of New Stable Datums in the field of Standard Dianetics and Dianetic Auditing.

New Stable Datum #1 = IF AN F/N OCCURS ON A THIS LIFETIME IN-CIDENT, AND IT IS BASIC ON THE CHAIN, END OFF RIGHT AFTER IN-DICATING THE PC's F/N.

Earlier HCOBs on the HSDC Checksheet may have indicated otherwise, specifically:

- HCOB 6 May 69 "R3R Revised". In page 4, there is a
- paragraph called "F/Ns vs Erasure". Disregard it.

 HCOB 14 May 69 "F/N and Erasure". The first paragraph, up to "Tone Arm Position" (title of 2nd para-
- graph) does not apply precisely that way anymore. HCOB 23 June 69 "F/N" The portion from "When a Key-3. Out occurs..." all the way down to "...sent to Review for a Scientology Green Form." can be improved.
- HCOB 3 July 69 "Health Form and Somatics." In page 2, the paragraph, "Ending Off," is also being revised and improved.

New Stable Datum #2= A PC OR PRE-OT CAN OWN A CHAIN, BASIC OF WHICH CAN BE A THIS LIFETIME INCIDENT.

On a case like this, erasure does occur, of course, as the first incident (earliest) on the chain is reached and handled (erased).

If you really duplicate the word "Basic", whether in Dianetics or Scientology, this would be very real to you.

STANDARD RULES FOR F/Ns OBTAINED ON A THIS LIFETIME INCIDENT.

1) If an F/N occurs while running a this LT (lifetime) incident, and your PC has GIs or VGIs, very probably a cognition too, YOU ASK: "DID THAT INCIDENT ERASE?" If he says "Yes", and the F/N continues, END OFF RIGHT THEN.

- 2) If an F/N occurs while running a this LT incident, with GIs, VGIs, and/or cognition, YOU ASK: "DID THAT INCIDENT ERASE?" If the PC says "No", and the F/N stops, check for an earlier incident or an earlier beginning as the case may be, and complete the chain to basic.
- 3) If an F/N occurs while running a this LT incident with GIs or VGIs, cognition or not, you also ask, "Did that incident erase?" If he says "yes", yet the F/N stops, you end off that chain anyway. Accept the pc's data.

If it wasn't basic on the chain, it will be proven as such sometime, maybe in a matter of minutes, days, months, years, no one knows when the somatic will key-in again, if ever. All we know in a case like this (3) is that if indeed the chain was erased, the somatic you ran on that chain will not key-in again, ever. If it does key-in, then you know why your F/N stopped when you asked "Did it erase" when F/N occurred in the first place.

Stable Datum When a basic is reached and erased, THE MERE ACTION OF CALLING OFF THE ITEM TO THE METER WILL PRODUCE AN F/N.

Stable Datum If a basic on a chain has been reached, erasure and F/N obtained, and you continue auditing, you are going to end off in a real fire-fight, entangled in a mess from where you'll be very glad to get your pc and yourself out.

What we are trying to avoid by this new technique is the ploughing of pcs and preOTs into earlier track when it was not necessary at all, and where judgement based on reality of a situation is of most value. Actually, when one is on OT III or above, more reality on the subject matter is available. What one is trying to do though, with efforts, is the creation of a "better" betterment of the being, and we hope that this HCOB will help clear up any difficulties you may have had in the past.
