CONFESSIONAL REPAIR LIST

LIST L-CR

The rule on an HCO Confessional is that it should always end on an F/N. There are various means of obtaining this. When it does not F/N however the person must be routed immediately to Qual and this list used to repair and obtain the F/N.

This action is a 24-hour REPAIR PRIORITY.

To not repair within 24 hours leaves the person hung with a possible overt, certainly with an unflat (or overrun) action and he is liable to get sick, misemotional or leave a trail of entrubulence and destruction behind him until the matter is handled.

The list is taken to the first F/N Cog VGIs and then ended.

Preliminary Step: Ascertain the time of the Confessional to the person's satisfaction. Prefix the questions with "In that Confessional ".

- Did you have an ARC Break? (If so, handle by ARCU CDEI itsa earlier similar.)
- 2. Did you have a problem?
 (If so handle itsa earlier similar itsa).
- 3. Did a withhold get missed?
 (If so, get it. If discreditable ask "Who nearly found out?".)
- 4. Was there a false read?

 (If so, find out what it was on. Ask "Who said you had a when you didn't?").
- 5. Was there a false accusation? (Itsa e/s itsa.)
- 6. Was anything suppressed?
 (Get what it was and itsa e/s itsa. If a suppressed ARC break handle as in (1).)
- 7. Was anything invalidated? (Itsa e/s itsa).
- 8. Was anything protested? (Itsa e/s itsa).
- 9. Was there an evaluation? (Itsa e/s itsa)
- 10. Was a question asked that wasn't flat?
 (If so get which question and flatten it).
- 11. Has an overt been protested?
 (If so get what it was, get in protest button on it, check for earlier).
- 12. Was there an earlier overt undisclosed?
 If so get it, take the chain down to basic).

- 13. Were you withholding anything?
 (If so get what it was. If discreditable take it earlier similar).
- 14. Was a chain of overts not taken back to basic? (If so take it to basic).
- 15. Was the Confessional overrun?
 If so indicate BPC and rehab).
- 16. Was the action unnecessary? (If so indicate the BPC).
- 17. Was there an injustice? (If so indicate BPC).
- 18. Was there a betrayal? (If so indicate BPC).
- 19. Was there some other kind of Bypassed charge?
 (If so find out what it was and indicate).
- 20. Has the upset been handled? (If so indicate).
