## TECHNICAL CROSS INDEX

This booklet is a cross index intended to help Case Supervisors locate easily technical references. It does not give authority or provide any recommendations whatever on what process to use or actions to take to handle a case. In a few instances the commands of a process are given to help the Case Supervisor find the particular HCOP, HCOB, tape or book where these particular commands are given. Before any process is used, the HCOP, HCOB, tape or book containing them must be consulted and HCOP 8 Mar 66 (High Crime) followed.

This cross index contains many of the references a Case Supervisor may need to refer to. Since you will find additional references, space is provided to add them. Where only a date is given it refers to an HCOB issued on that date, with the title the same as the index line. In most instances where the title of the HCOB is different than the index line, the title or subject matter is given in parenthesis following the date. Occasional reference is also made to booklets containing magazine articles on the Level 0 and Level 11 Checksheet and the Level 0 and Level 1 PABS for the SHSBC. The abbreviation CHA stands for Creation of Human Abilities.
