TRS IN AUDITOR TRAINING AND CRAMMING

As of now, every new Interne enrolling for training is to do the TR Course as a qualifying action. They continue until they can actually DO natural TRs.

Every Auditor sent to Cramming, no matter what the cramming cycle is, whether it is a TR, Admin or Auditing error, is to do TRs in Cramming as a required action.

He does not start any other action in Cramming until he can actually DO natural TRs.

The reference for the above is contained in HCOB 21 June 71 (Issue III) Training Drills Modernized.

"Due to the following factors, I have modernized TRs 0 to 4.

- The auditing skill of any student remains only as good as he can do his TRs.
- Flubs in TRs are the basis of all confusion in subsequent efforts to audit.
- 3. If the TRs are not well learned early in Scientology (R) Training Courses THE BALANCE OF THE COURSE WILL FAIL AND SUPERVISORS AT UPPER LEVELS WILL BE TEACHING NOT THEIR SUBJECTS BUT TRS.
- 4. Almost all confusions on Meter, Model Sessions and Scientology or Dianetic (\widehat{R}) Processes stem directly from inability to do the TRs.
- A student who has not mastered his TRs will not master anything further.
- 6. Scientology or Dianetic processes will not function in the presence of bad TRs. The preclear is already being overwhelmed by process velocity and cannot bear up to TR flubs without ARC Breaks..."

CURRENT STUDENTS

Any Auditor on an Interneship at the time of receipt of this BTB will do TRs the Hard Way on a part time basis until he has completed the TR Course and qualified as above, still maintaining his quota of auditing hours.

In a recent talk to Qual, LRH mentioned the following regarding Cramming:

"Cramming is not a vacation for Auditors who goof.
An Auditor is expected to keep auditing his hours and cram in his own time, unless the Cramming order specifically states 'off auditing'."

However, the Auditor may not audit the action he goofed nor the PC he goofed on until the Cramming cycle is complete.

Every Cramming Section and Interneship is to have copies of early LRH auditing sessions to use as models of natural TRs.

The Qual Sec. Cramming Officer, TR Course Super and Interne Super are to listen to these tapes until they are thoroughly familiar with natural TRs, and are able to correct Auditors and Internes into natural TRs.

The Org's Internes and Auditors are to listen to the Model Tapes until they really get the idea of natural TRs, and until they AUDIT LIKE THAT.

Org's Intermes are to regularly make tape recordings of their own sessions - certainly the first few times they audit a new action they haven't yet audited on the Intermeship.

Internes are to be checked out beforehand by the Interne Super on how to operate the tape recorders to get the best recording quality. The presence of the tape recorder and the purpose of doing the recording are to be cleared with the PC beforehand.

After the session Interne Super listens to the tape with the Interne and issues pink sheets to correct flubs in commands and session procedure and any outnesses and unnaturalness in TRs.

An Interne can re-use the same tape when the old session has been heard.

ONLY LRH sessions may be used as models for Auditors. Qual may not authorize the use of a local Auditor's tape as a model. Any LRH Auditing Tape the Org has in stock

may be so used. All Orgs should also have and use the LRH demonstration and TRs Tapes.

The purpose of this BTB is to make it understood by Qual Secs, Cramming Officers, TR Course Supers and Interne Supers that TRs are THE most vital part of an Auditor's training and that any attempt to minimize their importance will result in turning out bad Auditors and making enemies for Scientology.
