AUDITOR'S PROCESSING CHECK HOO WW SEC FORM 6A

(For use by Class II or above Auditors only.)

This is a shortened version of HCO WW Sec Form 6, the valuable Processing Check for auditors to get off their overts on preclears. Many old Scientologists' cases will not progress until this check is done.

Redone by Mary Sue Hubbard. it has been reduced from 174 questions to an essential 80 questions.

Use only a British Mark V Meter in doing this check. Frequently ask "Has a withold been missed on you?"

The questions: "What didn't an auditor know about you?" and "What didn't a preclear know about you?" should also be cleared on the needle.

If you have to end a session with a question still reacting, tell the PC, "This question is not yet nul" before going into end rudiments.

On all questions implying a critical attitude, ask also "What had you done to a preclear?" Don't endlessly try to clear off critical thoughts, these are always only indicators that the person being checked has committed an overt against what he or she is criticizing. Critical thoughts, comments and attitudes toward something indicate always a prior actual overt. The actual overt must be found which caused the later critical attitude. To fail to locate the prior overt is to tend to miss a withold. You can clear critical thoughts for hours if you don't contact the overt. Contact and pull the overt and save hours and hours in doing the Processing Check.
