CLASS VIII RETREAD

TRAINING AND AUDITING

REQUIREMENTS

The cycle of a retread is programmed. It is targeted. It is carried right up to the completion of all its targets.

It is started by the Study and Revision of all materials covered in the current checksheet that the student is now re-reading. It is continued by the Auditing actions the student - Auditor performs as per the materials he is re-reading. It is completed by a confirmed Certification and Classification of the Auditor on the course he has retreaded.

At Flag, we received 3 Class VIIIs, who were Provisionals, we proceeded exactly as above, and those VIIIs were made Full VIIIs after their retread.

They had been Provisionals for just about a year. So you see, a Retread accelerates the advance - pace of an Auditor.

They studied their materials as many times as required in order for them to know their Tech backwards and forwards. They audited very well and they were rewarded as such.

WHAT did they retread ?  
WHAT AUDITING did they do ?  
HOW LONG did it take them ?

Well, they all were HDGs, and Provisional VIIIs when they arrived. We knew their auditing background as Pcs and as Auditors. That was a good ingredient to know and to have.

They covered the materials contained NOW, in the HSDC checksheet ; then, they took an exam and passed it 100%. They audited. Two of them did very well as Auditors and were put on HDG. ONE flubbed technically and administratively more than twice, even with reference, corrective to the materials she flubbed on technically and administratively. She flubbed once more, so she got sent back to RETRAIN 3 TIMES thru the checksheet. WHY ? Because she already was supposed to have been on HDC, yet it was later proven she didn't know the Tech of HCOB "How Not To Erase!!"

How many Auditing sessions did they do ? They did as many as they had to in order to meet their Retread Program Requirements.

The three of them eventually ended up together re-reading the VIII Course. They took an exam and passed 100%. They audited ALL actions an VIII can name.

They Case Supervised all kinds of folders.

They left FLAG, as FULL VIIIs, Powerful and are representing the Sea Org in various areas of the world, as "Keeper of Tech" mainly, but not necessarily.

So you see, it's not all that hard to do.

What one has learned out of the experience of Retreading VIIIs, who also must be HDGs of course, is that the whole cycle is prepared, planned, put out as a program, completed and then its personnel get sent out to the field, on another cycle, a Tech Program of some sort generally, the pattern of which is exactly the same as the Retread one.

Thus, the following Training and Auditing Requirements are hereby made Official and Standard requisites on Policy :

I - HSDC

1) The student first star-rate checks out 3 times on any new materials.

2) He/she then studies the current checksheet once, covering ALL materials.

3) An exam is taken and must be passed 100%.

4) The student Auditor performs the following auditing actions, at the satisfaction of the local C/S :

- CS 1
- CS 2
- Dianetic Singles
- Dianetic Triples
- Prior Assessments
- Dianetic Remedies for Sick Pcs, Past Lives, Pictures and masses etc...
- Reassessments and R3R (Single or Triple)

II - HDG

If 1, 2, 3, 4 above are all done perfectly, the student auditor now retreads the HDG as follows :

- 1) Checks out Star-rate three times on all new materials.
- 2) Covers all of the HDG Checksheet once.
- 3) An exam is taken and must be passed 100%.

If 3 and 4 of HSDC are flunked, the student retrains the whole HSDC checksheet 3 times thru, and when he meets points 3 and 4 of HSDC, only then he/she retreads the HDG as designed above.

---

III - CLASS VIII

When the HDG study and exam requirements are met, the Student now :

- 1) Checks out Star-rate on any new VIII materials, 3 times.
- 2) Studies all of the Class VIII Checksheet once, tapes and all,
- 3) Sits an exam - Passing Grade 100%.
- 4) Audits the following :
  - Single Grades 0 to VA
  - Triple Grades 0 to IV
  - Standard Reviews - (GFs - LX lists - GF40s - Prep-checks - Itsa Processes - Listing Processes.)
  - Any other action the local C/S feels the Auditor hasn't very well or not at all handled as yet.

NOTE : No specific number of sessions required is mentioned anywhere.

IV - CASE SUPERVISION

When all the above is done successfully, the Class VIII Auditor now does an Internship of Case Supervision, as covered by HCO Policy Lettter of 6 December "The Case Supervisor Checksheet" Issue III.

THIS SECTION OF THE CLASS VIII RETREAD IS NOT FREE OF CHARGE. ITS FEES WILL BE MADE KNOWN BY CS-3, LRH FINANCE AND MATERIEL AIDE.

Needless to say that the Class VIII Retread is carried out, from its beginning to its end, exactly and strictly within the Laws and Rules of Standard Tech. Any VIII who has had a very successful record of auditing as an Auditor and Pc can do it. It is simple, sharp, fast and very precise. It took about 3 weeks for the VIIIs mentioned earlier to complete the retread as stressed in this letter.

All the VIIIs throughout, whether on Retread or not, already are and will remain THE VIIIs in the world. They graduate from the Retread as HUBBARD SCIENTIST OF STANDARD TECH, on top of their Class VIII Title and Status.

One of YOUR and OUR duties will be to keep Standard Tech applied exactly as written by L. RON HUBBARD, wherever you or we may be, and we are to SAFEGUARD it as such.
