PAID RELEASES, CLEARS & OTS

LRH COMM STATISTIC

(NOTE: This HCO PL has been updated to include additional valid Release attainments, in line with the new Classification & Gradation Chart.)

The statistic of the LRH Comm includes Paid Releases, Clears and OTs. This stat comprises:

Method 1 Word Clearing Completion
Life Repair Completion
Objective Processing Completion
Drug Rundown Completion
CS-54RD Completion
Recall Release (ARC Straightwire)
Standard Dianetic Case Completion
Communications Release
Problems Release
Relief Release
Freedom Release
Ability Release
Expanded Dianetics Completion
Power Release
Power-Plus Release
Grade VI Release (R6EW)
Clear
Each OT Level

All processes and all 3 flows as necessary to declare a person for a Release, Clear or OT Level must be run.

If Expanded Grades are done on a previous Release or OT, the attainment of each Expanded Grade counts on the statistic.

The statistic is counted one for one - one point for each item listed above. Each of these is a valid technical completion for the stat of Paid Releases, Clears and OTs.

USE OF THE STAT

LRH Comms know by this statistic whether or not the org is producing completions, and making full and correct use of valuable org auditing hours by exact application of HCOBs. And by relating this stat to other GDSes he knows whether or not the org is there and functioning. By further analysis of GDSes and by observation of the Divs concerned he knows which areas need what LRH EDs, PLs, HCOBs, exactly applied in order to remedy the production and organization and establishment faults which hold his Releases stat down, and by remedying them increase all GDSes including his own.

RAISING THE STAT

It should be noted that an order such as "push training" will if competently executed raise Releases since the best auditors trained will work in the Org either as internes or Staff auditors (or both) and by the excellence of their training deliver excellent results which will increase demand for processing. The continued push on training will increase the rate of flow. Excellently audited pc's will become excellent auditors who produce results on pc's.

Further study will show how all GDSes relate to the orgs VFPs and stats and how the way to maintain a high Releases (and Clears and OT) stat is to enforce standard policy form and actions throughout the Org, always bearing in mind that Releases are produced by well-trained Auditors.

The LRH Comm's observation and analysis therefore extends throughout the whole org.

He must know and enforce Finance Policy so that he knows what level of production is required to make the org viable and so that the org's money is invested in that which maintains or increases viability; he must know and enforce Promotion Policy to ensure raw materials of enough volume to bring about a viable level of production; he must know and enforce Ethics Policy so that Tech can function to correct all raw material to VFPs at a rate and quality that ensures viability.

Furthermore, execution of his duty to his FOLO/CLO and Flag - completion of Flag Programs and Projects, full reports of whatever prevents completion of Flag Programs and Projects - ensures that Flag has the real data to observe real Whys on a planetary scale that enables LRH and Flag to formulate the Policies and Plans, to mount the Programs and Projects for Orgs that will on completion improve conditions and production, thereby increasing his stats - GI as well as Paid Releases.

NETWORK INTER-RELATIONSHIPS

All LRH Comms must understand their position with regard to their orgs' internal operations and with regard to the operations of FOLOs/CLOs, Flag and the Founder.

Anything encountered by the LRH Comm in his post, product, purpose, hat, org board, duties, functions, actions, command lines, comm lines, or any other area of his concern, which is not clearly and fully understood by him in the framework of the foregoing MUST be instantly referred via the Continental LRH Comm to CS-7 at Flag for clarification.

In this fashion counter-policies, counter-orders and any inversion of the Awareness, Sanity and Admin Scales or of the Key Ingredients can be picked up and handled.

Without conscientious action of this nature on the part of every LRH Comm no LRH Comm Network can exist in anything like a viable condition, and no LRH Comm can expect to reach any very causative position over his stats of GI and Releases.

We have taken the opportunity of this clarification of what is counted as a Release to give an R-Factor on the relationship of the stat to the LRH Comm post and indirectly of the relationship of the post and its stat to the Dept 21 VFP: The Technology of Scientology and Dianetics and its Products.

In working the relationship of the parts of Dept 21 and of the sum of the parts to this product, it must be done with the full recognition that the DEMAND FOR the CONSUMPTION OF and the UTILIZATION OF the Technology of Scientology and Dianetics and its Products is UNLIMITED.
