PUBLIC REG BONUS

In addition to basic staff pay the Public Registrar is entitled to receive the following weekly bonuses:

1% of the money collected by the Public Reg that week.

Such bonuses are paid when the service is entered. No bonus is paid on a sign up who has not started the service signed up for.

A Public Registrar in order to receive the bonus must have her New Names to C/F stat and Public Reg Paid Starts stat in normal or above.

NON-DELIVERY

The Public Reg is responsible for ensuring her sign ups This is what she receives bonuses for. However a Tech Division not delivering can unjustly deny the Public Reg her bonuses. Lack of delivery can stem from Org failure to get a TEO trained at Flag and posted in Div 4 and this also will endanger Public Reg bonuses.

Therefore if the Tech Division fails to deliver or HCO fails to get a person sent to Flag for TEO the Public Reg has the right to request DIRECT of the LRH Comm, Office of LRH, that a Court of Ethics be convened on the offending parties. If the matter is serious a Committee of Evidence can be requested by the Public Reg.

If the local Office of IRH fails to immediately deal with the matter to the satisfaction of the Public Reg, she may telex or cable the nearest C/O CLO or C/O FOLO for an ethics mission. If the telex or cable is stopped by local Org terminals the Public Reg may go outside of the Org and send it herself at the nearest Post Office.

The Public Reg may NOT be intimidated or undergo ethics action for any of the above actions in trying to correct non-delivery and persons violating this become subject to Committee of Evidence locally or through a Sea Org ethics mission.

PAYMENT OF BONUSES

The bonus due is calculated from Income Invoices the Public Reg writes with paving person's signature on them. Payroll Treasury Div 3 sees that the bonus is paid from the Disbursement Account.

If it is found that such bonuses have been acquired through false reports, the Public Reg is liable to Court of Ethics. If the Court of Ethics finds the Public Reg guilty then the Public Reg is personally fined for the amount illegally obtained. The fine is paid to the Org.

INTENTION

The intention of this Policy is to encourage and reward good valid production by the Public Reg and to give the Public Reg recourse to protect her post.
