These, however, can be summarized into the following classes of Whys:

This list is assessed by a Scientology Auditor on a Meter. The handling directions given in each case are designations for auditing actions as done by a Scientology Auditor and are given in the symbols he would use.

1. Misunderstood Words. _____
Handled with Word Clearing (Method 1 and Method 4 of the Word Clearing Series.)
2. Inability to Study and an inability to learn the materials. _____
(Handled by a Study Correction List HCO B 4 Feb 72.)
3. Outpoints in own thinking. _____
(Handled by what is called an HC (Hubbard Consultant) List HCO B 9 April 72.)
4. Personal cut Ethics. _____
(Use P/L 3 May 72 by an auditor. Has two Listing and Nulling type lists)
5. Doing something else. _____
(2 way Communication on P/L 3 May 72 or reorganization.)
6. Impatient or bored with reading. _____
(Achieve Super Literacy. LRH Executive Directive 178 International)
7. Doesn't know how to read statistics so doesn't know where to begin. _____
(Learn to read stats from Management by Stat P/Le)
8. Doesn't know the scene. _____
(Achieve familiarity by direct observation.)

9. Reads on and on as doesn't know how to handle and is stalling. _____
(Get drilled on actual handling and become Super - Literate.)
10. Afraid to take responsibility for the consequences if wrong. _____
(HCO B 10 May 72 Robotism. Apply it.)
11. Falsely reporting. _____
(Pull all witholds and harmful acts on the subject.)
12. Assumes the Why before starting. _____
(Level IV Service Facsimile Triple Auditing.)
13. Feel stupid about it. _____
(Get IQ raised by general processing.)
14. Has other intentions. _____
(Audit on L9S or Expanded Dianetics.)
15. Has other reasons not covered in above. _____
(Listing and Nulling to Blowdown F/N Item on the list.)

(Get them off.)
17. Has had wrong reasons found. _____
(C/S Series 78.)
18. Not interested in success. _____
(P/L 3 May 72 and follow as in 14 above.)
19. Some other reason. _____
(Find it by 2 way comm.)
20. No trouble in the first place. _____
(Indicate it to person.)
