CONFESSONAL AIDS - SALE OF

(Ref. BPL 9 July 1969  
"Confessional Aids...")

Confessional aids, Hubbard Electrometers, are religious artifacts employed in the Church of Scientology Confessional.

As such, they may be sold only to Ministers in good standing of the Church of Scientology (R), or bone fide Ministerial students.

The following contract is to be filled out by anyone wishing to purchase a meter. The completed contract is then to be filed in the Church's Val Docs.

CONTRACT FOR PURCHASE OF CONFESSONAL AIDS (E-METER)

WHEREAS the Hubbard Electrometer is a sacramentally privileged article of faith used by Ministers of the Church of Scientology as a confessional aid.

WHEREAS the meter measures spiritual activity and does not, nor is it intended to, diagnose or cure any physical ailment.

WHEREAS as a holy article of faith of the Church of Scientology, the use of the E-Meter is limited to those few who are recognized by the Church as privileged to have the use of the E-Meter.

WHEREAS it has long been Church policy that only ordained Ministers theological students preparing for ordination, or those seeking the highest levels of spiritual awareness above Va may use or have possession of the meter.

Applicant being duly privileged by the Church to be invested with the use of the E-Meter by his/her being in the status of ordained Minister of Church/qualified theological student preparing for Ordination/or theological student seeking levels of spiritual awareness above Grade Va, warrants, covenants, and agrees as follows:

I realize that the E-Meter is a sacred article of faith of the Church and that it is not intended for, nor can it be used for the prevention, diagnosis, or treatment of any physical ailment or disease.

I confirm my vows as a Scientologist and pledge and contribute the sum of \_\_\_\_\_ dollars.
