## BOARD POLICY LETTER

22 JUNE 1974

## BOARD REPRESENTATIVES

Every Continental Area in the world is to have at least one Board Representative at Flag. He holds the post of Board Representative on behalf of the local Church Board by whom he is appointed.

This person is your own representative on Flag who knows your scene, is fresh from your area and can handle all the things that you want handled on Flag.

He does nothing but service your org and area.

Earlier attempts to get areas representated at an international level were at WW in 1967 (see HCO PL 8 Sept 67 Issue II "Continental Liaison Officers at WW" page 65 OEC Vol 7, and HCO PL 18 Oct 67 Issue II WW - "How to Comm to WW - Continental Liaison Officers" page 69 OEC Vol 7) and in the original forming up of the Flag Bureaux in 1969.

We will now accomplish that intention in full.

The BOARD REPRESENTATIVE is that officer appointed by the local Board of Directors as their principal management officer for the org of that Board.

The Board Representative is the governing head of the Org. He directs the Org toward expansion from Flag and does everything necessary at Flag to assist the CO/ED and execs of the Org to keep the Org viable and rapidly expanding.

The Board Representative constantly evaluates the Org and provides properly evaluated effective Flag Programs for his Org and area. His programs, directions and orders are mandatory upon the Org and must be complied with.

The FLAG REPRESENTATIVE is the Board Representative's terminal of execution of his orders from Flag.

#### ORG BOARD LOCATION

The post of Board Rep supersedes the Flag Programs Chief post, which is discontinued when replaced by a Board Rep. The post is located in the INTERNATIONAL BUREAU OF REPRESENTATIVES in the Flag Bureaux, which replaces the old Programs Bureau on Flag.

The Programs Bureau in the FOLO and the FOLO Programs Officer post remain unchanged.

The single command channel for orders to an org remains the same - Flag Commodore's Staff or Flag Executive to AVU to Board Representative for that Org to FOLO Pgms Officer for that Org to the Org Flag Rep and into the Org.

All Central Bureaux Orders, FBDLs, FOs and Policy apply to the Board Representative.

### REQUESTS AND QUERIES

Requests or queries may be addressed by despatch to the Org's Board Rep by the CO/ED or Flag Rep, or by others in the Org through those terminals.

## TERM OF OFFICE

The term of office of a Board Representative on Flag is a maximum of 1 year. He then returns to his area AND RELIEVES THE FLAG REPRESENTATIVE AT AN ORG OR FOLO who, having turned over his hat to his relief, goes to Flag and does a tour of duty as the Board Representative for that area on Flag.

The rotation of Flag Reps and Board Reps for areas is staggered throughout the year to eliminate any international crash possibility by reason of multiple Org or area executive changes.

This system accomplishes the dual purpose of keeping Flag Reps Flag-oriented and Board Reps with a high reality on their own org or area. It also allows regular training and brush-up.

Travel expenses both ways are paid by the org or area. Living expenses and allowances of the Board Rep on Flag are paid by Flag.

# TRAINING

Upon arrival at Flag a Board Rep goes into full time, crash training or retread for his post which usually lasts 2-3 weeks. This includes specifically Data Series evaluation training, Stat Management Policy, Targetting Policy, his hat and other essential post training. His post is meanwhile temporarily covered by the Board Rep of another area or Programs Chief.

Training and hatting continues part time with a minimum of 21/2 hours a day throughout the Board Rep's term of Office on Flag.

It is <u>not</u> the intention of this Board Policy Letter to have every org, small or large, individually represented at this time. However as orgs grow larger and increase in numbers representation will include less orgs per Board Rep.

Continental Areas with large numbers of orgs or with big orgs will have more than one Board Rep but these will be assigned to specific orgs.

Any Flag Rep in any org may be exchanged with a Board Rep on Flag.

#### SUMMARY

Each continental area shall have at least one Board Representative at Flag.

He is there to provide and get service, materiel, clarification and expertly evaluated effective Flag programs for the Org in that area.

The personnel holding the posts of Board Reg at Flag and some Flag Reps of the area or org will rotate at 1 year intervals.

The program includes regular, short, full time training and retread periods to increase competence and expertness.

Such a program gives each org and area true experienced representation at Flag to better handle their affairs.

It will vastly increase the rate of expansion of Orgs and of Scientology.

Get it in now.
