HCO POLICY LETTER OF 21 SEPTEMBER 1980R

NOTE: This policy is issued to SO Orgs and AOs as info only. It was not meant to imply that this was what was necessary for AOs to gear up for Solo NOTs. Solo NOTs is a Flag Only Service.

PERSONNEL REQUIRED FOR SOLO NOTs DELIVERY

The following personnel postings are the minimum required for Solo NOTs delivery to the public. These are additional to existing NOTs auditing delivery personnel.

1. SOLO NOTs CASE SUPERVISOR.

Qualifications: The Solo NOTs C/S must be an experienced NOTs C/S who has also been trained as a Solo C/S and has done the Solo NOTs Auditor Course.

2. THE SOLO NOTs AUDITOR COURSE SUPERVISOR.

Qualifications: The Solo NOTs Auditor Course Supervisor needs to be both an MCSC grad and a Solo NOTs Auditor Course grad.

3. SOLO NOTs AUDITOR COURSE WORD CLEARER(S).

Qualifications: The Solo NOTs Auditor Course Word Clearer(s) must have had auditing on NOTs (preferably case OK for Solo NOTs) and must be qualified as a Word Clearer.

4. THE SOLO NOTs CONSULTANT.

Qualifications: The Solo NOTs Consultant needs to be NOTs trained and to have done the Solo NOTs Auditor Course.

5. THE SOLO NOTs CRAMMING OFFICER.

Qualifications: The Solo NOTs Cramming Officer must be NOTs trained and have done the Solo NOTs Auditor Course.

6. SOLO NOTs REVIEW AUDITORS.

Qualifications: The Solo NOTs Review Auditors need to be experienced NOTs auditors who have done the Solo NOTs Auditor Course and have completed High Crime checkouts on the actions they will be doing.

7. THE SOLO NOTs D OF P.

Qualifications: The Solo NOTs D of P doesn't have to be a trained NOTs auditor but does have to have been audited on NOTs and it is preferable that he has done the Solo NOTs Auditor Course and has reality on Solo NOTs auditing.

8. THE SOLO NOTs COURSE ADMIN.

Qualifications: The Solo NOTs Course Admin does not have to be NOTs trained but does have to have been audited on NOTs and it is preferable that he is on Solo NOTs.

There are no special requirements for Tech Services personnel such as DTS, Folder Page and Tech Pages but these posts would have to exist.
