The certificate of SCIENTOLOGY MAGISTRATE shall be issued to any Sea Org Master at Arms or Ethics Officer who has completed the following:

A Sea Org MAA or Ethics Officer who has completed the above requirements may submit a CSW, including evidence of good post production and having met all requirements, to the International Justice Chief. Upon approval by the International Justice Chief, Establishment Executive International and AVC International, the MAA or EO may be issued and may display his certificate.

Such an MAA or Ethics Officer is thereafter to be referred to as a Scientology Magistrate. The full title, Scientology Magistrate, is to be used in Ethics Orders and other communications, along with the person's org board post title (e.g. Dir I&R or Chief MAA).

A Scientology Magistrate is charged with the responsibility of getting in ethics in his organization and area, including seeing that other MAAs or Ethics Officers in his area and junior to him are fully hatted, competent, and effective.
